 Commentary to the Fourth Geneva Convention, Article 3, J. Pictet (ed.), ICRC, 1956, p. 44: “Consequently, the fact of applying Article 3 does not in itself constitute any recognition by the de jure Government that the adverse party has authority of any kind; it does not limit in any way the Government’s right to suppress a rebellion by all the means – including arms – provided by its own laws; nor does it in any way affect that Government’s right to prosecute, try, and sentence its adversaries for their crimes, according to its own laws. In the same way, the fact of the adverse Party applying the Article does not give it any right to special protection or any immunity, whatever it may be and whatever title it may give itself or claim”.
